



ALUMNI MEDAL – Nomination Form

The Iowa State University Alumni Association established this award in 1948 to recognize ISU alumni for long loyal service to the university through alumni-related activities. The Alumni Medal is the premier award given to alumni by the ISU Alumni Association. Up to three awards may be granted annually. (Current members of the ISU Alumni Association staff, board of directors, and awards committee are ineligible to receive this award.)

Guidelines for submitting a successful-award nomination:

- Be sure to read the award descriptions carefully to ensure you are nominating the person for the award that fits the nominee most appropriately.
- The information submitted by the nominator is what will be used to determine the strength of the award nomination. Be thorough with the submitted information.
- When nominating a “couple” for the award, be sure both individuals meet the selection criteria. Each person will be judged as if they are being independently nominated.
- To best represent your nominee, please follow the nomination format closely. Respond to the criteria requirements in the numerical order as listed under the Selection Criteria heading. Essay type submissions that don’t follow the exact criteria order make it difficult to capture the necessary information to meet selection guidelines.
- Only three recommendation letters will be accepted. Additional attachments or information and recommendation letters will not be considered so that each nominee is judged equally in the selection process.

Please list applicable information in each of the following categories and three letters of recommendation, in addition to the nominator’s summary.

1. Nominator’s summary explaining why this person should be chosen for this award and evidence of the candidate’s long loyal service to the university through alumni-related activities
2. Current/past affiliation with the ISU Alumni Association (member, board of directors, reunion or other committee members, ISU Ambassador, ISU Club Leader, Parent’s Association etc.), Foundation, Memorial Union, Colleges, Athletics, or other university related entities
3. Iowa State University honors, recognitions, and awards

All nominations are kept on file for one year following the year in which they are originally considered, if not selected that first year. Nominators are encouraged to update nomination materials yearly.
